09:45 A United Front For Sport Integrity

Corruption has, unfortunately, become engrained in modern day society. It is not a problem exclusive to sport - rather it permeates all industries, undermining the rule of law and our fundamental ethical values. In many ways, sport reflects society, and the corruption we hear about is systematic of the problems faced by leaders across all sectors and industries.

After decades of poor governance and lax attitudes by sports governing bodies and governments, the reputation of sport has reached an all-time low, due to the destructive impact of corruption. The need for global leadership, meaningful reforms and enhanced international corporation is greater than ever.

The important questions to discuss in this session include: Why has corruption remained a barrier to integrity reform in sport? What is being done to eradicate corruption from sport? What legacy will we leave for future generations if the issue of corruption is not tackled head on? Rather than accepting the status quo and lamenting the lack of legal instruments, how will we take action now on a global level within the sport sector?

11:00 Keeping Corruption & Criminal Infiltration Out Of Sport

Sport has been confronted with the most serious and devastating integrity crisis in its history, showing that the need for concerted action has never been greater and more urgent. The problems are simply too big and too widely known to be ignored.

While corruption and criminal infiltration spread out in sport, exposing its current vulnerabilities and undermining its integrity, so do the forces trying to eliminate them.

But what exactly is being done by sporting authorities, governments, international organizations and law enforcement to stop crime in sport? With what means? How effective has international cooperation been in this field? Are sports governing bodies and regulators doing enough? What lessons can be learned from the past four years? And what new revelations will next be brought to light by law enforcement, court trials and the media? These are some of the questions to be addressed by the highest qualified experts in this field, including some of those who first initiated and now lead the criminal investigation and prosecutions on the case commonly known as "FIFA-Gate."

14:00 Sports Betting Integrity - The Future

In the past year, the U.S. Supreme Court has repealed the ban on sports betting and opened the doors for state-to-state legalization. Slowly, but inevitably, sports betting is becoming widely accepted. But the reality is clear: States, sports betting operators and sporting organizations are entering into unchartered territory, and the focus is being predominantly given to the awaited jackpot rather than sport integrity.

The U.S., Brazil and other countries are now opening their sports betting markets. How will they, as well as individual states, betting operators, sport organizations and law enforcement regulate this new landscape? What's the plan to prevent and combat the inevitability of illegal betting, match fixing, sport betting fraud and even transnational organized crime? What best practice can be learned from the European regulatory experience? Will the players, coaches, staff and other key participants be prohibited from betting within their own leagues? What supervision and information exchange mechanisms will be put in place? What level of cooperation between competition organizers and law enforcement will be implemented? What training and education, if any, is being planned, and what sort of safeguards will be available for the most vulnerable individuals in sport, the youngsters?
