A special word of thanks to our partners and committed supporters at George In the side-lines, we are preparing for a big and bold year, holding internal meetings, amending our Constitution and internal policies, ensuring that we are well represented across the international institutional architecture, as well as progressing on our own thought leadership initiatives with UNESCO and international organisations and partners. On a final note, we were saddened to hear of the tragic passing of Michael Pederson, founder of Change the Game and true champion of SIGA since the start of our journey. The group addressed a series of significant matters, including the extraordinary upcoming meeting of the Intergovernmental Committee for Physical Education and Sport (CIGEPS) in March 2019. Also discussed was the Milan4Sport Impact initiative to take place in 2020, focusing on Integrity, labour market and social inclusion. Meeting UNESCO-SIGA Kick-Off of joint project: "The Business case for sport integrity"

A high-level call took place between senior figures at UNESCO and SIGA on January 30 2019 to chart the next steps for our collaboration on a research and advocacy project seeking to identify the business case for promoting sport integrity. A list of key threats to sport integrity will form the initial basis for the next phase of work, which will involve many members from across SIGAs network.



SIGA Council Meeting

SIGA held its first Council meeting of the year in Rome on 31 January 2019 that marked the 2nd anniversary of the organsation and the first anniversary of the establishment of SIGA's internal organs. The Council reflected back on the success of 2018. Notably, SIGA getting its internal house in order as well as the successful negotiation of a number of high profile partnerships, hosting major sport integrity events as well as the launch of the international public procurement of the SIGA independent rating and verification system (SIRVS). Discussions then looked forward to SIGA's 2019 objectives of consolidation, expansion and delivery and continued growth and strengthening, both internally and externally, with thought leadership activities for the year ahead.

AFDP Global expert roundtable on situation of the Afghanistan Women's National Football team.



SIGA was represented at to the AFDP Global hosted roundtable of experts held on February 5 2019 to discuss solutions to the current situation relating to allegations of sexual abuse levelled towards senior figures in the Afghan Football Federation including the President who has been suspended by FIFA. The best interests of the players were at the core of the discussions, as well as the systemic change required to protect players, improve reporting mechanisms, establish restitution and prevent similar situations in the future. Participants included HRH Prince Ali bin Al Hussein, Kelly Lindsey, the Head Coach of the Afghan Women's National Football team and former US international, Mary Harvey, CEO, Centre for Sport and Human Rights, Moya Dodd, Executive Committee Member of the Asian Football Confederation, and Amanda Vandervort, Vice President Major League Soccer.

This event was hosted by George Washington University in partnership with SIGA Member Mastercard. During the Special Session the SIGA CEO, Emanuel Macedo de Medeiros committed to having this event on a biannual basis, promoting the implementation of SIGA's Universal Standards in Good Governance across the industry and confirmed that next year's event will be held in Brazil. SIGA ENTERS INTO PARTNERSHIP WITH U.S.

SIGA ENTERS INTO PARTNERSHIP WITH U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES

SIGA and two departments of the United States Government; the United States Department of Health and Human Services (HHS) and the President's Council on Sports, Fitness & Nutrition (PCSFN) announced a partnership to promote sport integrity across America and worldwide on 28 January 2019. This agreement is the first of its kind for SIGA with a U.S. Government entity and represents a key milestone in the parties' efforts to safeguard sport globally.

The partnership is a strong strategic fit, leveraging the parties' respective strengths, across three main objectives:

- Sports' positive values and social, educational, and cultural role;
- Good governance, integrity, and transparency in sport; and

- Development and protection of children and young people in and through sport.

Emanuel Macedo de Medeiros, CEO of SIGA stated: "Today's

announcement is another solid step in SIGA's journey and recognition of its vital role. The relationship with the United States Government and the President's Council, now formalized, represents a powerful opportunity to instigate the much-needed reforms and restore people's trust in sport. Through our combined efforts, we are committed to encourage other governments to join us at the forefront of the fight against corruption in sport."

Holli Richmond, Executive Director of the U.S. President's Council on Sports, Fitness & Nutrition stated: "The President's Council on Sports, Fitness & Nutrition looks forward to working with SIGA on making a collective impact in the sport integrity space. There is so much to be done in the United States, not only to encourage more kids to play sports but also ensuring that they have access to the resources that keep them safe."

SPECIAL UPDATE: SIGA Independent Rating & Verification System (SIRVS)

The SIGA Independent Rating and Verification System (SIRVS) is an integral part of SIGA's ecosystem to usher sport and the wider sporting industry into a new era of enhanced governance, integrity, transparency and accountability. In a nutshell, SIRVS is the game changer that the sports industry needs. The purpose of SIRVS is to assess and rate the sporting organisations' level of implementation of and compliance with the SIGA Universal Standards. In order to ensure impartiality, SIGA decided to appoint a third party to operate the system, with SIGA retaining overall supervision and strategic control. To this end, SIGA launched an international public procurement process in June 2018 and appointed an independent Jury to carry out an analysis of the tenders from the respective bidders.

Having received an overwhelming response to the SIGA Invitation to Tender and after several months of intense work, the Jury has conducted an in-depth analysis of each bidder's response and submitted their final report to the SIGA Council on 14 February 2019. The SIGA Council have an extraordinary meeting on 1 March 2019 to make the final decision and the outcome of the SIRVS tender will be announced on 26 March 2019 at the fifth edition of the SIGA Sport Integrity Forum, held at the New York Athletic Club. This will be followed by the launch of the pilot phase.
