




### Inception

The seed for a new era in sports integrity was sown in the discussions of sports stakeholders in Geneva and New York in 2015. From the First Financial Integrity and Transparency in Sport Forum to the agreement signed by 20 leading international organizations, the idea of SIGA was nurtured by a common sense of urgency to tackle the challenges facing Sport. By 2016, important steps like the drafting of the Statement of Intent & Declaration of Core Principles in London, and key meetings in Madrid and Paris, paved the way for SIGA's formal launch as a global, independent, and neutral sport integrity board. This journey led to the adoption of the first SIGA Universal Standards in January 2017, marking a new chapter in sports governance.






### Legal Incorporation

### 31 JANUARY 2017

After nearly two years of intense dialogue highlighting the need for a global coalition in Sport Integrity, SIGA was formally incorporated as a legal entity in London on January 31, 2017. This pivotal day transformed a shared dream into a tangible reality, birthing

a movement that, seven years later, celebrates the selfless contribution of thousands of individuals and hundreds of organizations towards sports integrity. SIGA founding members were: The McCain Institute; Portuguese Sports Foundation; ICSS Insight; La Liga; Organization of the Turkic States; UIA,

IMMAF; Etishpere; quest; CANOC, Dow Jones; Special Olympics; Basel Institute on Governance; Portuguese National Plan for Ethics in Sport; Portugal NOC; Cyprus Sports; Svensk Elitfotboll; M-INC; Deloitte; ADIT; LEN Aquatics; Pivot Sport; World Taekwondo; Kosovo NOC; ESIC; Trindad & Tobago NOC.

### **SIRVS**

The SIGA Independent Rating and Verification System (SIRVS) stands as a testament to SIGA's dedication to measurable and accountable reform in sports governance. Launched as an independent tool, SIRVS evaluates compliance with SIGA's Universal Standards, offering a transparent and objective assessment. This system not only reinforces accountability but also serves as a guiding

light for organizations striving to meet the highest standards of integrity in sport. The European Rugby League was the first sports organization to become SIRVS certified in 2021, and the Portuguese Professional Football League followed their steps in 2023. Dozens of sports entities are currently going throught other SIRVS steps, such as SIRVS gap analysis, towards Good Governance in Sport.

### SIGA Women **Programme**

The SIGA Women Programme, launched in 2018, champions gender equity in Sport as an essential aspect of Sport Integrity. It comprises of the SIGA WoW show, thought leadership events, and the SIGA Women global mentorship programme. This programme has influenced over 200 women across various continents. Initially, the mentorship involved 16 mentors and mentees, and it now extends its reach to more than 150 women globally every year. A significant feature of the programme is the Summit on Female Leadership in Sport, an annual event at the margins of the UN International Women's Day. For the third consecutive year, Mastercard will host this summit in New York City on 6 March 2024.

### **SIGA Youth Council**

Established in 2020, the SIGA Youth Council (SYC) empowers young leaders to actively participate in shaping the future of sport integrity. Welcoming individuals aged 18-29, the SYC is a unique platform for the youth to voice their perspectives on integrity-related issues in sport. With a mission to support SIGA's global agenda, the SYC members lead various projects and initiatives, driving positive change and ensuring the youth's active involvement in promoting good governance in sport.



### SIGA Universal Standards on Sport Integrity

The Universal Standards, born from extensive research and expert consultation, represent a dynamic framework for enhancing sports governance. These standards, embracing international benchmarks and best practices, address the unique realities and challenges of global sport. Recognizing the diverse capabilities of sports organizations, SIGA encourages the adoption of these standards through a phased approach - Bronze, Silver, and



to democracy, integrity, transparency, and accountability in sports. In 2022 SIGA launched the Universal Standards on Youth Development and Protection, closing the circle with Good Governance, Sports Betting Integrity, and Financial Integrity in Sport.

### **Sport Transparency Index**

The Sport Transparency Index is an innovative initiative funded by the European Commission. This tool objectively evaluates and ranks the transparency levels in European sports, setting new standards in governance and integrity. The Sport T-Index project is a collaborative effort involving 15 organizations from over 10 European nations, aiming to enhance integrity in sports through a comprehensive mechanism that benchmarks stakeholders against transparency indicators. This initiative marks a significant step forward in facilitating and measuring good governance across the sports

I am passionate about SIGA

and its' Reform Agenda, as it's a project I've been working on since its inception seven years ago. SIGA is a concept whose time has come. There was a vacuum in terms of international standards for the world of Sport. SIGA has created those standards, tailored them to the industry and amended them to reflect evolving best practice. Simultaneously SIGA created a global movement of like-minded organisations, and we are growing that membership base on a daily basis. We've created the standards; we then carefully created the SIRVS rating system. This goes back to the DNA of SIGA.
