ne of the highlights of this period was, undoubtedly, our International Expert Forum on Financial Integrity and Transparency in Sport, commonly known as The FITS Forum. Hosted by Winston & Strawn LLP in New York, with the invaluable support of Richard Weber (Partner of the referred to law firm. former Chief IRS - CI Officer and Chair of SIGA's FITS Committee), the Forum convened 80 leading organizations from the world of sport, government, law enforcement and global business, and culminated in the announcement of the "New York FITS Declaration". Summarizing the common views of the participants, this Declaration sets forth the seven critical objectives:

- Adoption of SIGA Universal Standards on good governance and financial integrity.
- 2. Ensuring compliance through the SIGA Independent Rating and Verification System (SIRVS).
- 3. Establishing a **Global Independ**ent Clearing House for financial transactions in Sport.
- 4. Creating a **Sport Integrity Fund** from broadcasting rights, sponsorship deals, and sports betting revenues.
- 5. Enhancing legislation aimed at preventing and repressing of financial crimes related to Sport.
- 6. Strengthening financial integrity, transparency and supervision rules related to the organization of major sports events, sponsorship deals, and broadcasting arrangements.
- 7. Ensuring lawful, transparent and accountable **public funding allocations to Sport**.

leading the SIGA delegation that attended the **Corporate Chess World Cup**, organized by SIGA's member International Chess Federation (FIDE), and deliver a keynote during the tournament. This event provided a powerful platform to emphasize the importance of adopting SIGA's Universal Standards and SIRVS to all Organizations that wish to enhance their capabilities and validate their Governance.

In Amsterdam, **Soccerex Europe** was the ideal venue to address Football Integrity with leading industry figures. Continuing our European engagements, we had a very productive meeting with UK Sports Minister Stuart Andrew. Our discussions centred on the ongoing UK Football Governance Reform, the role of Government in implementing best practices and how SIGA can support these efforts moving forwards.

True to our action-oriented ethos, we initiated meetings of all the Permanent Committees of **SIGA LATIN AMERICA**. The engagement from top Continental experts was both infectious and inspiring, with a clear roadmap for progress established. The same happened with the **SIGA Permanent Committees**, who met during this period.

To enhance our capacity-building and regulatory framework, **SIGA** and our independent commercial arm, **SIGA SOLUTIONS**, signed a commercial agreement with **APC Compliance**, one of our newest members, to boost integrity, transparency and accountability in sports.

n regards to growing the critical mass that supports our ambitious reform agenda and helping to facilitate the next generation of Sport Leaders, we encourage you all to explore the following opportunities, circulate these through your networks and encourage any suitable candidates to apply:

# FITS FORUM: US Law Enforcement and Sports Industry Support SIGA's Reform Agenda

ver 80 senior representatives from sports, global business, US governmental agencies, and law enforcement gathered at the FITS Forum in New York to tackle pressing challenges in financial integrity and transparency in sports. Hosted by SIGA AMERICA and Winston & Strawn LLP, experts highlighted concerns about corruption, money laundering, and tax evasion, among other topics.

Participants unanimously supported SIGA's mission and proposed reforms, emphasizing the need for enhanced stakeholder cooperation, robust governance, regulatory frameworks, and independent oversight. The Forum concluded with the launch of "The New York Declaration on Financial Integrity & Transparency in Sport," outlining steps for greater integrity and transparency.

Emanuel Macedo de Medeiros, SIGA Global CEO, urged participants to support SIGA's reform agenda, emphasizing the necessity of a united front to protect sports integrity. The FITS Forum's collaborative efforts and the New York Declaration mark significant progress in safeguarding global sports through the SIGA Universal Standards and SIRVS. It's time for global sponsors, governments, and sports organizations to join this movement.

# High-level meeting with the UK Sports Minister

n May 22, SIGA was received officially by the United Kingdom Sports Minister Stuart Andrew. The meeting had the participation of SIGA's Global CEO Emanuel Macedo de Medeiros, SI-GA's COO Katie Simmonds and the co-chair of Siga Europe Advisory Board, Lord Jonathan Marland. The most pressing challenges of Sport in the country have been discussed, including the creation of the Independent Football Regulator. SIGA's Universal Standards on Sport Integrity, and the SIGA Independent Rating & Verification System generated interest, and bridges for effective collaboration were established.

# SIGA calls for reform in Brazil

Emanuel Macedo de Medeiros, Global CEO of SIGA, stressed the urgent need for reforms in Brazilian legislation to better support youth development and training clubs. Speaking at a Public Hearing on Training Clubs in Brazil, co-hosted by Senator Eduardo Bandeira de Mello and various sports organizations, Macedo de Medeiros highlighted the complexity and inadequacy of current laws. With 31 years in sports management, he noted the disparity between Brazil's 778 professional clubs and only 56 certified clubs. He called for increasing these numbers and improving governance standards, emphasizing youth development as a core pillar of SIGA.

# Emanuel Macedo de Medeiros extensive interview with A Bola

manuel Macedo de Medeiros, Global CEO of SIGA, discussed the state of Sport Integrity in an extensive interview with Portuguese media outlet A Bola. He highlighted how the FIFAGate scandal revealed systemic corruption, prompting SIGA to establish Universal Standards in four key areas: Good Governance, Financial Integrity, Sports Betting Integrity, and Youth Development & Protection. Macedo de Medeiros stressed the importance of integrity in Sport for maintaining competitive balance and societal value. He called for rigorous regulation, especially in combating racism and match-fixing, and urged

all stakeholders to embrace SIGA's standards to ensure sports' ethical future.

# Pilot study phase completed

The Sport Transparency Index project has recently completed the pilot study phase which saw over 80 Sport Organisations assessed in accordance with the Index methodology. The project partners will soon be completing the validation assessment of the Index methodology criteria and begin the final assessment of over 450 Sport Organisations from across Europe. The final version of the Sport Transparency Index will be released in 2025.

The outcomes of this groundbreaking project will work to improve standards by shining a light on current capacities and concurrently creating the means to facilitate positive change through associated education, policy recommendations and knowledge exchange initiatives and we look forward to bringing this to fruition and engaging with all likeminded stakeholders throughout the process.
