

The evolving socio-economic global climate and escalating global tensions bring increasing uncertainty, instability, and anxiety. Sport may not be able to operate miracles, but, in times such as these, it can certainly help to unite, inspire and fortify us, on individual, collective and international levels, provided that Sport is delivered, perceived and governed in the way we all aspire it to be: with Integrity. This is SIGA's raison d'être, and the experience, skill and understanding of the complexities of the delivery of these goals are the reasons why we are a globally significant, growing and thriving organisation.

As in previous years, 2023 saw the breadth, depth and commitment of our global coalition stand up and be counted. What we achieved, as a cohesive and aligned collective over the course of the year was nothing short of outstanding. As such, I am delighted to share this rendering of accounts with you, our members, committed supporters and the broader sporting ecosystem.

It was through robust, collective action and our growing critical mass that we were able to impact upon Sport in so many ways and help to usher this incredible industry towards a brighter, robust and sustainable future. The path has been set, the journey is underway and yet there is still far to travel.

All our achievements are a testament to us acting as a global, united front, supported by a growing membership base and an ever-increasing network of committed supporters, like-minded partners, and champions in Sport Integrity.

We hope you will view this Annual Report of Activities as a galvanising summary of our collective efforts and continue to share our common purpose and work with us to create and reshape a new landscape for the entire Sports Industry.

The year began with the election of SIGA's independent Chair, the Ethics Committee, and the Audit & Compliance Committee.

We also saw the first Football League (Liga Portugal) go through our Universal Standards and be awarded with the SIRVS Certification.

Leading the way for Sport Integrity worldwide, we organized and/or participated in a vast number of important projects, initiatives and thought leadership events, such as:

- SIGA Summit on Female Leadership in Sport, in New York, USA;
- SIGA Global CEO's appointment as member of B20 India and participation on the B20's Partnership Summit, in New Delhi, India;
- OECD Global Anti-Corruption and Integrity Forum, in Paris, France;
- Everything in Sport Women's edition event, in London, England;
- SIGA LATIN AMERICA's and Pacto pelo Esporte's joint CEOs Dinner, in Sao Paulo, Brazil; and

- Sport Integrity Week 2023 in September that saw a multitude of leading events hosted around the World that combined to create the largest, most engaging and dynamic Sport Integrity Week to date;
- SIGA Global CEO's participation, with speaking role, on the 21st session of the UN's Intergovernmental Working Group on the Effective Implementation of the Durban Declaration; and
- International Anti-Corruption Week, in December, including a Special Session at the COSP / UNAC, in Atlanta, Georgia, USA;

We also led and/or were directly involved in several other thought leadership initiatives and formalized a number of action-oriented, reform-driven partnership with extremely influential institutions, through the signing a several Cooperation Agreements. These included:

- Launch and kick-off of our ground-breaking Sport Transparency Index, a game-changing project that SIGA is leading with the support and engagement a range of European partners under the European Commission's Erasmus+ funding stream;
- · Signing of a Cooperation Agreement with UN Women;
- Signing of a large-scale Cooperation Agreement with the Minister of Sport of Brazil;
- Signing of a Cooperation Agreement with the Parliamentary Front for the Modernization of Brazilian Football (Brazilian Congress):
- Official Launch of development process of the Independent Study on the Future of Football in Brazil, commissioned to SIGA and SIGA LATIN AMERICA by the Brazilian Congress through the Parliamentary Front for the Modernization of Brazilian Football;
- Signing of Memorandum of Understanding with IACA;
- Release of the SIGA Youth Council Survey on "New Perspectives on Sport Integrity"; and
- Launch of new editions of the SIGA Sport Integrity Journal.

The year witnessed also a significant evolution of the SIGA Global Mentorship Programme for Aspiring Female Leaders connects now 150 women. With remarkable SIGAWomen-led! 75 mentees are accompanied by an equal number of female leaders. Together they forge their path in the sports industry, making a decisive contribution to female empowerment, developing crucial tools, skills and networks in the pursuit of better governance and greater gender equity in Sport.

Celebrating the International Women's Day, we held another high-level SIGA Summit on Female Leadership in Sport, hosted for the second time by SIGA's founding Member, Mastercard. Held in New York, this event connected more than 200 people, in person, with thousands more joining online via our live-streaming, further

delivering on our objectives to ensure our events are accessible, inclusive and empowering.

The Sport Integrity Week 2023, our flagship thought leadership event, surpassed all expectations and was the largest and most impactful in SIGA history to date. SIGA events were organised on every continent and these were supported and extended by the inclusion of around 70 other events, delivered by independent hosting partners under the Sport Integrity Week umbrella. In this document, we report how organisations like São Paulo FC, Liga Portugal, and so many others acted to #SideWithSIGA during this monumental week!

The launch of the Sport Transparency Index - having successfully received ERASMUS + funding – served as a critical milestone for progressive impact that is based upon tangible outputs that better serve the Sport Stakeholder Community and an important step in the diversification of our income streams, enabling us to be ever more productive.

SIGA's commitment to providing a platform and opportunity for the next generation of Sport Leaders has long been established. 2023 saw the conclusion of the second iteration of the SIGA Youth Council, which culminated in the release of their New Perspectives on Sport Integrity Survey report and corresponding Sport Integrity Journal article. We look forward to welcoming the third iteration in 2024. In 2024, we will continue our efforts to serve our Global Community and grow our membership base.

We will continue to look to diversify our revenue streams to ensure we are ever more productive, pragmatic and responsive to the evolving needs of this incredible Industry. And to ensure that our independence remains intact.

As this Annual Report of Activities demonstrates, we have worked incredibly hard to be where we are and will continue to do so. There is a lot more to accomplish in the 12 months to come. We will continue to build upon the foundations we have put in place and strive to do justice to the effort of those that work with us in our endeavours.

It is by remaining aligned to our foundational core values and encouraged by what has gone before, that we can all be confident and ready for whatever the future will bring. 

On March 3rd, the members of SIGA unanimously rafitied the election of Giovanni Tartaglia Polcini as the new independent and non-executive Chair of the SIGA Council. He follows in the footsteps of SIGA's inaugural Chair, Franco Frattini, who passed in 2022. Giovanni Tartaglia Polcini, an Italian magistrate, has served as a Public Prosecutor for nearly two decades. At the time of his election, he held the position of senior Legal Advisor at the Ministry of Foreign Affairs of Italy, where he also led anti-corruption efforts and co-chaired the G20 Anti-Corruption Working Group. Additionally, since 2015, he has represented Italy as an anti-corruption delegate to the OECD Working Group on Bribery and has overseen multiple technical assistance initiatives through the Italy/ International Italo-Latin American Organisation (IILA).

The purpose of this institutional expansion aims at promoting the highest integrity and governance standards in Sport, throughout the whole region, as part of an ongoing global reform to restore the sector's reputation and regain its much-needed credibility. To this end, SIGA LATIN AMERICA is committed to working with all key public and private stakeholders, in a framework of positive dialogue, constructive cooperation and mutual respect.

In 2023, SIGA Latin America established solid roots in the sports, political, and social spheres, mobilizing partners from all corners of the continent, with a greater presence in Brazil.

Cooperation agreements were signed with UN Women Brazil, the Ministry of Sport of Brazil, as well as the Brazilian Congress and Parliamentary Front for the Modernization of Brazilian Football. The groundwork for collaboration was laid with the Brazilian Football Confederation (CBF), finalized in 2024.

Relevant Latin America sponsors have joined SIGA as members, such as Accor, C6 Bank, Yduqs, Passarelli and Sicredi. With them São Paulo FC also joined our global community, playing a crucial role in events like the SIGA Latin America Forum and the Integrity Match.

Originally established in 2020 as a Task Force, the SIGA GRID Committee established a Task Force on Race, Gender, Diversity, and Inclusion that issued a set of recommendations to the SIGA Council, including the amendment of the SIGA Universal Standards on Good Governance in Sport, to positively impact diversity and inclusion factors in the boardroom of sports organisations. These recommendations were unanimously approved by the SIGA Council and ratified by the SIGA General Assembly on 12 April 2021.

They have subsequently been incorporated into the SIGA Universal Standards on Good Governance in Sport. This Task Force has since been transformed into a Standing Committee on Gender, Race, Inclusion and Diversity. The Standing Committee met regularly throughout 2022 and made extensive contributions to the thought leadership events throughout this calendar year, engaged in the most pressing issues as they emerged.

In September, during the Sport Integrity Week 2023, Emanuel Macedo de Medeiros, SIGA Global CEO, Chair and CEO of SIGA LATIN AMERICA, signed with a cooperation agreement with the Brazilian Sports Ministry, represented by the Minister Ana Moser. VII. Thought Leadership Initiatives Universal Standards on Sport Integrity









The year 2023 brought a new dynamic to the Universal Standards. Three years after the creation of the Universal Standards in Good Governance, Financial Integrity, and Sports Betting Integrity, and a year after the launch of the Universal Standards for Youth Development and Protection in Sport, SIGA reviewed them and released the 2023 edition.



Following the MoU signed in 2021, the Portuguese Professional Football League (Liga Portugal) adopted in 2022 the SIGA Universal Standards for Good Governance in Sport and assessed their degree of compliance through SIRVS in 2023.

In August 30th, LIGA Portugal was awarded Bronze certification on Good Governance in Sport, and became the first Professional Football League globally to go through SIGA's Independent Rating and Verification System.

Liga Portugal received SIRVS certification for Good Governance in Sport, and as a result of this investment and the expansion into Latin America, the Good Governance standards were translated into Portuguese, facilitating procedures for future SIRVS certifications in Portuguese-speaking countries.

It is time to move from words to actions, and SIGA reinforces the invitation to all organisations to, further than adopting the standards, going through to the SIGA Independent Rating and Verification System (SIRVS). As a first step, SIGA is offering to conduct an internal gap analysis of sports organisations, including leagues,

to provide an x-ray of where they are currently in relation to the SIGA Universal Standards on Youth Development and Protection. SIGA will then collaboratively work with sports organisations to create a 12-month action plan to get them on a pathway of enhanced Governance, ready for SIRVS.

Independent Study on the Future of Brazilian Football



This project, unveiled during Sport Integrity Week 2023, garnered unanimous and enthusiastic support from the audience at the Congress in Brasilia during the Special Session to launch the Concept of the alluded Independent Study.

SIGA LATIN AMERICA has also developed and successfully submitted the Implementation Plan of the Independent Study to the Parliamentary Front for the Modernization of Football, including all relevant phases. consultation mechanisms and procedures, advisory organs and expert groups, etc.

Commissioned by the Brazilian Congress through the Parliamentary Front for the Modernization of Football, chaired by Congressman Bandeira de Mello, the Independent Study on the Future of Brazilian Football is an initiative of SIGA LATIN AMERICA. With broad participation from Brazil's key stakeholders, including CBF, state federations, major clubs, athletes, as well as dynamic and influential organizations, personalities, and experts representing sponsors, television operators, media, and civil society, this study aims to provide a comprehensive. rigorous, and impartial diagnosis of the main vulnerabilities and pressing challenges facing national Football. It also aims to recommend the most appropriate legislative, strategic, and operational reforms to safeguard the integrity of Football and its sustainable development.





"Brazilian Football cannot afford to waste more time. If it truly wants to enhance its reputation, restore its credibility, and strengthen its global appeal in what is an increasingly competitive and fast-paced global industry, the need for action is greater than ever. 

VII. Thought Leadership Initiatives

The Sport Transparency Index

The Sport Transparency Index project was approved as part of the Erasmus + Programme. The Sport Transparency Index is an innovative tool to objectively rank, compare and contrast base transparency levels in Sport in order to facilitate, measure and improve minimum standards of good Governance and integrity in the sector.

This project will see SIGA lead a collaboration of pioneering organisations from over 10 European nations.

This 30-month project, which began in 2023, will deliver the mechanism to evaluate European Sport Stakeholders, including Clubs, Leagues, National Associations and International Governing Bodies against a robust set of Universal Transparency Indicators.

The ambitious project will map the European Sport Transparency landscape and deliver both the mecha- nism to evaluate levels of transparency of good Gover- nance and the means for the Sport industry to enhance the way it operates.

The deliverables include, amongst others, a publicly available Sport Transparency Index, a range of Digital Training Packages to enable knowledge exchange and a set of Policy Recommendations that will combine to facilitate greater Integrity throughout European Sport.
