Since 2019, SIGA has conducted an independent research into the percentage of women's representation at the highest executive organs of the 32 international federations recognised by the International Olympic Committee.


Female Representation on Executive Organs of International Federations



Executive Summary

It has been a privilege to lead SIGAWomen since 2018 when SIGA's Global CEO, Emanuel Macedo de Medeiros, set me the challenge of creating a global mentorship programme to narrow the gender gap in terms of female representation on the board of sports organisations globally.

Initially, I must admit, I wasn't enamoured with the idea of being a poster girl for gender equity in sport as I had experienced firsthand how tough it is to be accepted for your credentials as a female sports lawyer and was used to being the only woman in the room. Why did I want to highlight my gender when this has been a barrier? However, once I discovered how taking one aspect of SIGA's Universal Standards on Good Governance in Sport – Gender Equity as the Gold Standard – and creating a programme that was accessible for women – could be so impactful – I was sold! Today SIGAWomen has become not just part of my portfolio of responsibilities, but a passion that has driven me to take it to new heights.

I am proud that over the past 5 years we have delivered mentorship to +300 women worldwide, creating a safe place to address topics that are tough to raise internally

and arming mentees with all the smart answers, we wish we would have said, but often couldn't find our voice. At our fourth SIGAWomen Summit on Female Leadership held last year in New York, I set ourselves the challenge of doubling the impact of the 2024 Programme – moving from connecting 150 women annually represented from 32 countries to 300 women. Why? – because I believe that every female leader knows at least one other great woman to join – and I believe in the power of each of the global mentor's career stories as a dynamo for change.

If we want gender equity in sport, yes – we need male champions. We also need an army of female leaders that support aspiring women and equip them with the confidence and expertise to know their value and embark on a leadership journey. What we don't want is competitive women, holding onto the fact that they are the only woman, which sadly I have experienced all too often, and which, regrettably, I am not alone.

That is why I am thrilled that the members of the newly formed SIGAWomen Council, consisting of female leaders from all sides of the sports industry, with representation from each continent, have said yes! They play a key role to the global expansion of our mission and on behalf of SIGA, I thank them for accepting our invitation and being agents of change. SIGAWomen's mission is unstoppable, and I invite you to join us as we make 2025 our biggest and best mentorship programme to date!
